Faith, Family, Friends Student Guidelines

- I agree to be respectful towards my teachers and fellow students in abiding by the rules during co-op. I realize that failure to do so could result in being expelled from co-op.
- I agree to complete all assignments given to me by my teachers. If I do not understand, I will ask for help.
- If I do not complete assignments for 2 weeks, I will be sent to Study Hall so that I can finish them.
- I agree to come to class prepared with pens, pencils, paper and other materials specified by my teacher.
- I agree to participate in class and clean up after class, as directed by my teacher.
- I understand that it is my responsibility to contact my teachers when I am absent and complete missed assignments in a timely manner.
- I understand that bullying: physical, verbal or relational. No hitting, kicking, slapping, or punching. There is no tickling or touching of private areas. These behaviors and/or intentional cruelty in any form will NOT be tolerated at co-op.
- I agree to practice self-control. I will WALK inside the building and use a SOFT, INSIDE voice. I will respect others' property and do my share to maintain the facility.
- I agree NOT to use any personal electronic devices during class time, unless instructed by teacher.
- I agree NOT to bring any weapons to co-op.
- I agree to only view G-rated materials on my devices that are Christ honoring during my F 3 day. I commit to no low-cut clothing, or clothing exposing the midriff. No cleavage.
- No clothing advertising alcohol or displaying vulgar, racial, or "gray area" language or inferences.
- Shorts must be modest and extend at least to the middle of the thigh. Shorts must have an inseam of at least 3 inches. Short and pants must be worn around the waist. Underwear may not show.
